UCU Wales welcome the opportunity to contribute to the Public Services Staff Commission White Paper: Devolution, Democracy and Delivery and wish to endorse the response submitted by the Wales TUC. We would however like to take the opportunity to make the additional comments.

We welcome social partnership and share the vision of a world class public service, delivered by a skilled and supported workforce. However, once again we would like to voice our concern and frustration that Further Education Institutions are excluded from the proposals. Although we are aware of the reasons behind this exclusion; that is the ONS reclassification of Further Education Institutions, we remain unconvinced by the arguments used to support the decision to reclassify and the resulting legislation.

In our opinion, there is a growing need for the protection and support of Further Education and its workforce, as a public sector service. We are in agreement with the First Minister, in the belief that:

"Public services must remain public. Their value lies in their universal availability, and in the potential for public organisations, including the third sector, to work together to improve the wellbeing of citizens and communities. We cannot leave that to the market. If we turned public services into commodities, provided them competitively and allocated them according to ability to pay, we would destroy what we have sought to preserve." ¹
