CEEC Annual Meeting

The CEEC annual meeting took place 14th November, 2024 online and had over 50 attendees across the day.

The meeting saw two panel discussions:

1) Morning Panel Discussion – Empowering Workers to Build a Sustainable and Just Future

2) Afternoon Panel Discussion – Empowering Learners to Build a Sustainable and Just Future

There were also six breakout discussions on topics including:

- 1) Promoting the “justice” in climate justice
- 2) Building alliances in and around workplaces
- 3) Making the internal case for green reps
- 4) Working with Union Learning Reps to support just transition
- 5) Making the health and safety links for sustainability
- 6) Education for a just transition
