## Campaign Demands

- A comprehensive review of the current operation of the Prison Education Service
- The PES to be overseen by the Department for Education and run as a national prison education service on a not-for-profit basis.
- A comprehensive review of the recommendations from the Coates review to inform these current proposals
- The implementation of the Joint Unions in Prisons Alliance (JUPA) recommendations and safer prisons
- A national contract for prison education staff and professional respect and parity of esteem with FE
- HM Treasury to confirm the application of Fair New Deal for pensions as a matter of urgency

## **Your Reps At UCU Congress**

Your reps attended UCU Congress in Liverpool recently. A motion was carried which resolves: to continue organising and campaigning to secure a better future under PES; prioritise work on the New Fair Deal; continue the campaign for a single contract for prison educators; advocate for a wider curriculum; train all reps in the TUPE process.

A motion requesting changes to the UCU organisational structure to accommodate the fact that prison education branches are based in several UCU regions was remitted. It will now be considered by the NEC (National Executive Committee.)

## **New Prison Education Providers**

An announcement will soon be made about which providers have been awarded the new contracts for prison education. Your union will keep in touch with you throughout the process and provide help where needed. All reps are being offered TUPE training which covers the rules when prisons transfer to different providers.
