UCU adopts environment policy - and wins plaudit of chief scientist

UCU has adopted policy which commits the union to play its full role in promoting the principle of sustainability. The 2007 Congress resolution unanimously passed – moved by Graham Petersen of South Thames College branch and seconded by John Fletcher President of Aston University LA – calls for UCU to:

- Develop the environmental role of union reps,
- Promote sustainability via the curriculum,
- Act at institution level to develop sustainable workplace polices and practices.

22 - Environment (South Thames College)

UCU recognises:

- 1. The ecological impact of national and global policies and activities which are damaging the ecosystem
- 2. The need for the adoption of the principles of sustainability to combat these policies.
- 3. The positive role which the education sector can play in promoting sustainability.

Congress therefore commits UCU to:

- 1. Promoting action at institution level to develop sustainable workplace polices and practices, such as 'greening the campus'.
- 2. Developing the environmental role of union reps and campaign to extend legal rights to paid release for their duties and training.
- 3. Contributing to efforts to promote sustainability via all elements of the curriculum.
- 4. Support appropriate organisations and campaigns in pursuit of these objectives.
- 5. Instruct UCU NEC to organise a fringe meeting on the environment at the 2008 UCU Congress.
- 6. Explore the policy options for reducing the 'environmental footprint' of UCU.

CARRIED UNANIMOUSLY

Sir David King, the government's chief scientific advisor, was a guest speaker at UCU Congress and gave a detailed, illustrated presentation on how human activity has contributed to climate change - and on the grave seriousness of the situation. He congratulated UCU for adopting its new environment policy.

Many UCU health and safety reps are already engaged in local discussions on institutions' environment policies. The intention of this newsletter and other initiatives is to respond to the new policy, to provide support for reps, and to give all interested UCU members a chance to contribute to this work.

Your news and ideas are sought. We are discovering that a good deal is already happening in many universities and colleges to make some effort to address environmental concerns, but we would like to have a fuller picture, to inform our efforts.

2. 93 UCU reps say: 'Our institutions are not doing enough on environment'

The recent Labour Research Department survey on the environment got the highest rate of response of any union from UCU with 93 reps responding, suggesting there is considerable interest out there and a growing understanding of the importance of responding to climate change. Etc

Amongst the 93 UCU responses, you should note:

- 18 said the environment was already on the bargaining agenda but only 9 said there was a joint union-management agreement on environmental issues
- 17 have negotiated time off facilities for reps to carry duties and undergo training for environmental issues but 2 have been refused such time off

3. Successful UCU Congress environment fringe

The environment fringe meeting at UCU's first Congress was a success. Caroline Molloy, the TUC's Green Workplaces project leader, outlined the rapidly growing involvement of unions in environmental issues in the workplace, nationally and globally. She outlined the TUC's work, including TUSDAC - a forum for national unions and government to jointly develop sustainable policies, and the Green Workplaces project which is creating partnerships between unions and employers to lessen workplace environmental impact by measures including energy and waste reduction and travel-to-work schemes.

UCU rep Graham Petersen reported from South Thames College on how one such scheme is working, and on his role in TU Education in the training of environment reps. Delegates exchanged news and ideas and everyone present signed up to the new UCU environment network.



4. TUC conference on 'Environment policy and the climate change bill'

Roger Kline, Graham Petersen and several UCU members attended this 4 June conference. A fine speech by TUC deputy general secretary Frances O'Grady stressed the importance of putting response to climate change at the heart of trade union activity including the recruitment and organisation of new members and the negotiating agenda.

"That this House notes the warnings set out in the Stern Report about the potential economic effects of climate change; strongly welcomes the fact that the Climate Change Bill will legislate to reduce carbon emissions by 60 per cent. by 2050; believes that trades unions and their 6.7 million members have a vital role to play in this task by working for best environmental practice in the workplace by negotiating sustainable workplace agreements with employers; notes that the Department of Trade and Industry is currently reviewing facilities and facility time for workplace representatives; and urges the Government to use this review to respond positively to the campaign for trade union environmental representatives to be given the same rights at work as other trade union representatives."

An Early Day Motion posted by John McDonnell MP calls for an increase in HSE resource. 76 members have already signed; please ask your MP to sign this EDM.
