UCU Environment Policy 2011-12: Report from Congress 1. May, 2011

Motion 27 entitled '1 million climate jobs' commits UCU to undertake work in 5 areas. It reads:

At a time when large numbers of lecturing jobs needed to deliver sustainability training are at risk, UCU must organise at institution, community, and national level to:

- appoint Green Reps in every branch
- introduce course offers that promote low carbon skills
- develop local alliances to increase the supply and demand for energy efficiency and renewable sources of energy
- liaise with FHE sector bodies to implement a coherent qualification framework
- support the 1 million climate jobs petition and march.

This newsletter will keep you informed of progress. Our ability to influence developments will be highly dependent on our success in delivering the first action point on appointing Green Reps. We currently have around 100 reps in the FHE sector. Our aim is to try and appoint at least one in every branch and association before Congress 2012. This is an ambitious target at a time when existing officers are stretched to the limit on other terms and conditions issues, but if we maintain the progress of the last 12 months it can be done. We will be producing UCU Guidance this term on the 'Appointment of Environment Reps'. We are consulting our reps to get examples of good and bad practice to use as case studies.

Motion 28 on 'Nuclear Power' reaffirms our opposition to nuclear power and in favour of renewable technologies. UCU is supporting the anti-nuclear protest at Hinkley on October 3rd. Find out more information from the Stop new nuclear site.

3. Low Carbon Skills

As the main post-16 trade union the Government's skills policy will have a big impact on our members. The publication of the 'Enabling the transition to a green economy' report published in August fails to provide the coherent strategy needed for the FHE sector to close the green skills gap. We are still waiting for the final draft of the green skills document which is designed to supplement the green economy document.

UCU convened a meeting of the Greener Jobs Alliance in September to discuss a response. It was agreed that we should launch a Green Skills Manifesto in the Autumn to address the shortcomings of government policy. We will be a circulating a draft in October for comment and launching the manifesto in November.

Green investment boost in Scotland – More than 80 new jobs have been promised at the Edinburgh Centre on Climate Change following a £1.6m injection from the Scottish government. Plans are in place to build a new home for the centre at Edinburgh University. Research into climate change and the development of low-carbon products and services will be carried out at the new base, due to open in 2013.

The Scottish government believes the low carbon market is valued at £8.49bn with a total of 4,098 companies in the sector, employing 73,000 people. Government forecasts predict it will grow to about £12bn by 2016, with low carbon employment in Scotland predicted to increase to about 130,000 jobs by 2020.
