ELECTION OF UCU REPRESENTATIVES 2018-2019

I write to inform you that I am organising the nomination and election of local Union Representatives (Reps) and Health and Safety (H&S) Reps in prison education departments; and Union Learning Reps (ULR) and Equality Reps across regions.

We rely on local Reps to distribute and disseminate information to members and to ensure that members' views and concerns are raised with your employer both locally and nationally. It is in your interest to make sure that you have a local Rep to deal with day to day issues relating to your employment.

It is also important that the Union has a Rep in every establishment so that members can receive support and advice promptly. The Union relies on local Reps to be the first point of call for members who need help. UCU staff will provide support and assistance when required and depending on the seriousness of the issue.

I also urge you to consider electing a Health and Safety Rep, especially given the challenging environment of your workplace. H&S reps have a vital role to play in improving the prison where you work.

The role of the Union Learning Rep (ULR) is key given the importance of continuing professional development in your profession.

UCU is also committed to ensuring that staff do not suffer discrimination at work, so we are also asking you to elect an Equality Rep.

Please note that for the ULR and Equality Reps, these will be regional roles - the region as currently defined by OLASS 4.

THE PROCESS AND TIMETABLE ARE OUTLINED BELOW.

If you are elected/nominated to any of these positions, you will be entitled to paid time off to carry out your duties. UCU has negotiated a facilities system with your employer to ensure you can carry out your Union duties as a Rep. The Union organises training for Reps and you will also be entitled to paid time off to attend this.

The timetable for the process is as follows:

- Nominations will open on Tuesday 7 August 2018
- Nominations to be received by 12pm (midday) on Friday 7 September 2018
- Ballot papers (if there is more than one candidate for a post) to be issued by Monday 17 September 2018
- Election closes 12pm (midday) on Monday 1 October 2018



• Results to be announced and notified by close of business on Tuesday 2 October 2018

The procedure will be as follows:

- 1. If you want to stand as a candidate for any of the positions fill in the nomination form and ask two other members to nominate you. You can run as a job share, but you must make this clear on the form. For a workplace position (general and H&S Reps) nominators must be from the same establishment, and for regional positions (ULR and Equality Reps) they must be from the same region/cluster. Make sure both are members.
- 2. Any current member can stand for the positions regardless of grade, type of contract etc.
- 3. A member can stand for one position in an establishment where they have a contract, and for one regional position in the region/cluster where they are based.
- 4. A separate nomination form must be completed for each position.
- Where a single valid nomination is received for a position, the nominee will be appointed. 5. Where more than one valid nomination is received, we will organise a secret ballot of members. For this purpose we will use the membership information recorded in the Union's membership database.
- 6. The period of office of the appointed Reps will be from 30 October 2018 to 29 October 2019.
