#### Result of Voting

<b>Yes</b>	<b>41</b>	<b>85.4%</b>
<b>No</b>	<b>7</b>	<b>14.6%</b>

c) that we have been able to carry out the functions conferred on us under section 226B(1) without any interference from the trade union or any of its members, officials or employees.
